





## NEED

- Classical education is a unique educational model not currently offered in the area
- Douglas County parents strongly support school choice and having diverse options available to meet their child's unique needs
- Recent polling of Douglas County residents found that public schools are favorable to a majority of voters (57% *favorable, 39% unfavorable*), and charter schools are even more favorable overall (63% *favorable, 23% unfavorable*)

## CHARTER SCHOOL SUPPORT

Charter school support increases to nearly 70% when voters know they are tuition-free public schools open to all children



#### WHAT IS CLASSICAL EDUCATION?

#### NEXT STEPS

- If the release is approved, the school's governing board will apply to the Charter School Institute (CSI)
- Application requires demonstration of community support and identification of a facility
- CSI will engage in a rigorous and thorough review of the application
- CSI's governing board votes to approve or deny the charter school application
