Collaborative Parent, Family, and Community Relations, Policy Subend (A)

Policy End: (IV-A) - Parents, guardians, families, and community members partner with each other and the District to empower students to maximize their individual educational experience.

Interpretation: Compliance will be demonstrated when the district promotes positive communication and collaboration between parents and schools around the needs of their students and plans for their futures.

Collaborative Parent, Family, and Community Relations, Policy Subend (B)

Policy End: (IV-B) - Collaboration with community, business, government, educational, and organizational leaders is sought to provide opportunities for students to create positive change and provide service in our community.

Interpretation: Compliance will be demonstrated when the district partners with the community to provide service, learning, and employment opportunities for our students in the community.

Evidence

- a. Student [Community Service](#) Hours - The community service hours for students are actively promoted and monitored. (Per BOE policy [IKF](#), students are required to complete 20 hours of documented community service hours in order to graduate.)
- b. [Career and Technical Education \(CTE\) Programs](#) - Career and Technical Education is a state designation for rigorous academic programs that offer a clear program of study under a qualified, credentialed teacher integrating real world learning to prepare students for high-skill, high-wage, in-demand career fields.
- c. [Concurrent Enrollment](#) - Concurrent enrollment provides high school students with the opportunity to enroll in postsecondary (college-level) courses and earn both high school and college credits with no tuition costs (excluding course fees and materials).
- d. [Work-Based Learning \(WBL\)](#) - DCSD offers work-based learning opportunities for students. Work-Based Learning is one way education and industry partnerships are partnering to ensure that students have the skills and career exposure needed to build pathways to meaningful careers.
- e. [Veterans Day Celebrations](#) - Many events are held each year in DCSD schools to celebrate and honor military veterans and their families on (or near) Veterans' Day.

Evidence

- f. Wish Week - (Video) - Wish Week is a fundraising campaign that is held in each DCSD school feeder area in support of the Kids For Wish Kids program and the Make-A-Wish mission to grant the wish of every eligible child.
- g. Strategic Partnerships - DCSD has been establishing strategic partnerships to create career pathways for students and to develop a talent pipeline for industry in Douglas County.
- h. Partnership of Douglas County Governments - DCSD is a member of the Partnership for Douglas County Governments.
- i. Chamber of Commerce Partnerships - DCSD is a member of every Chamber of Commerce within Douglas County and advertises in annual publications which are provided by Chambers to new residents, including Castle Rock Livability Magazine, Parker Visitors Guide and Member Director, and the Denver Relocation Guide. DCSD staff attends many Chamber events and meets with Chamber leadership regularly.

Collaborative Parent, Family, and Community Relations, Policy Subend (C)

Policy End: (IV-C) - Schools are the center of community learning, entertainment and gathering.

Interpretation: Compliance will be demonstrated when the district actively seeks opportunities to bring communities together, centered around our schools and our students.

Evidence

- a. School Communication and Engagement Support - DCSD provides schools with marketing and communications guidance.
- b. Career Pathways EXPO 2023 - DCSD held its second Career Pathways EXPO 2023 on October 26, 2023. Hosted by the District Accountability Committee (DAC) and the Foundation for Douglas County Schools, this event provided opportunities for families to gather information about the school district's many pathway programs.
- c. 8th Grade Career Expo - DCSD partnered with the Foundation for Douglas County Schools to host the 13th annual 8th Grade Career Expo at the DCSD Legacy Campus on Friday November 10, 2023. Over 1800 DCSD 8th Grade students visited with over 50 employers and had the opportunity to explore possible career pathways by asking questions, experiencing hands-on demonstrations and discovering possible career opportunities.

Director of Parent, Community and Civic Engagement - DCSD's Director of Parent, Community, and Civic Engagement continues to act as the liaison for DCSD's Lobbyist to advocate interests related to proposed legislation and other policy interests. The Director also assists the Board in implementing its Community Connections Plan.
- e. Wish Week - Wish Week is a fundraising campaign that is held in each DCSD school feeder area in support of the Kids For Wish Kids program and the Make-A-Wish mission to grant the wish of every eligible child.
- f. One Book, One District (OBOD) - DCSD partnered with the Douglas County Libraries and the Foundation for Douglas County Schools to host the 2nd annual #OneBookDCSD event during Fall Literacy Week, November 13th-17th.
