School Tax Bills

- Local Share of School Finance Act (Total Program) Funding: 27.000
- DCSD Mill Levy Overrides as approved by voters
 - 6 separate authorizations in 1989, 1997, 2003, 2006, 2018 and 2023
 - Authorizations total \$139,713,000
- Bond Redemption as allowed by statute to fund debt service on the District's voter approved General Obligation Bonds
- Abatement as allowed by statute for the District's proportional share of property taxes abated and refunded by Douglas County



Impact of SB23B-001 and Douglas County's 4% Reduction

- Special Legislative session in late November and SB23B-001 reduced home values for 2023 assessed value certification
- Delays timeline from dates set in statute
- Douglas County through Board of County Commissioners further instituted 4% across the board residential home value reduction



Calculating Mill Levies: Fixed Mill

• Calculation:

(Mill Rate x Assessed Valuation) / 1000

• School Finance Act Example:

Mill Rate		2023 Draft Assessed Valuation			<u>Approved Tax</u> Amount		
27.000	X	\$10,087,966,245	/ 1000	=	\$272,375,089		



Calculating Mill Levies: Fixed Dollar

• Calculation:

(Amount Required / Assessed Valuation) x 1000

• 2018 Mill Levy Override Example:

Approved Overr	ride Amount	2023 Draft Assessed Valuation			Mill Rate
\$40,000,000	/	\$10,087,966,245	x 1000	=	3.965



Calculating Mill Levies: Bond Redemption

- Type of fixed dollar mill set based on the amount of property tax needed to pay the tax collection year's principal and interest on outstanding bonds (bond redemption)
- Best practice to maintain 12 months of debt service payments in calendar year fund balance (June 2024 and December 2024 payments)
- Bond redemption mill recommended to reduce from 6.700 in 2022 certification to 5.345 in 2023 certification

Increase due to 2023 Mill Levy Override of \$66M
